The back of the lot is wooded and has 100% canopy coverage. The numbers are based on Tanksley Tree Service LLC. arborist, Stephen Murray, measuring the part of the lot that is not wooded and that was affected by the three trees (numbers 9-11) that were previously removed. The canopy measurements for trees 9-11 are approximate and knowledge based of the arborist by species and trunk size since they were removed before the tree plan was done.
