Mayor Tommy Alsup will host his quarterly forum for residents at 2 p.m. April 26 at Judson Baptist Church.


The forum will be held in Room 2106 of the church at 4900 Franklin Pike.



City has new procedures, streamlined processes

Before discussing a number of projects that we are currently working on, I would like to take this opportunity to express my appreciation for the warm welcome that I have received from all of Oak Hill.

I have enjoyed meeting a number of residents and look forward to meeting many more at the next mayor's forum. The city staff has been tremendous in making my transition easier and I would especially like to thank Mayor Alsup, Vice-Mayor McMullen, and Commissioner Throckmorton for giving me the opportunity to serve the citizens of Oak Hill.

We are currently assessing ways that we can improve the city website. We plan to add more information to the site so that it will be of greater use to our residents. While we have some ideas on the changes that need to be made, I encourage you to contact us and offer your ideas as well.

Streamlining processes

We are also streamlining several of our processes. As a first step in this effort, we are updating the Municipal Code Book. This process will take about two years and when we are done we will have a single book that we can turn to when a question arises about how our government should operate and what our rules and regulations are. This will be the first update of our code book since the early 1990s.

We are instituting new processes in our submittal and review of issues to come before the Planning Commission and Board of Zoning Appeals. We hope that this process will allow these two bodies to operate more efficiently and with a greater knowledge of the issues. It is our responsibility as staff to make this happen. However, this begins with the enforcement of submittal deadlines for issues to be placed on the agenda. Items for the Planning Commission should be submitted to our office 30 days prior to the meeting, and for the Board of Zoning Appeals the deadline is 14 days.

A strict adherence to these guidelines allows us to protect the rights of all citizens. We will also be purchasing signs to temporarily display as a public



notice on properties that are scheduled to come before one of these bodies for a hearing.

We plan to post the agenda for all meetings on the website no less than five days prior to the meeting. We believe that this allows us to protect the rights of all citizens by allowing them the opportunity to know when an issue will be heard and to be present to speak on the issue if they so choose.

Keep keys by bedside

If your car keys have a panic button, keep them beside your bed at night, says Oak Hill Safety Coordinator Tommy Jacobs.

It's a simple security alarm system that you probably already have and requires no installation. If you feel threatened, just press the panic button for your car. The alarm will be set off, and the horn will continue to sound until either

you reset it or the car battery dies.

You can set it off from almost anywhere inside your house. It works if you park in your driveway or garage.

If your car alarm goes off when someone is trying to break into your house, odds are the burglar or invader won't stick around.



To date none of the homes burglarized in Oak Hill has had a home security system. Although such systems do not guarantee a burglary-free home, they do provide some deterrent to criminals.

NEWS BRIEFS

Sound wall decision set for April

The City is getting close to constructing sound walls along I-65.

The evaluation committee recommended to the Board of Commissioners that the engineering design be awarded to Collier Engineering.

A 30-day delay was issued by the Commission. During this time, city staff will work to determine if new funding might be available for this project through the Tennessee Department of Transportation or through Federal Stimulus Funds.

This information will be reported back to the Commission at its April meeting, and a decision will be made regarding preliminary engineering for the project at that time.

Sign ordinance being updated

In an effort to protect the scenic beauty and residential character of Oak Hill, the Planning Commission is in the process of updating the city's decades-old sign ordinance.

The final product will undergo legal review, two readings, and a public hearing before it is enacted. The process could be finished by the end of June.

Funding approved for tornado sirens

The Board of Commissioners has approved all funding needed to proceed with the installation of two sirens in the Oak Hill area.

The City has awarded this work to the Metro contract holder, Stansell Electric. Oak Hill is purchasing and installing the northernmost siren and still assessing locations for the siren in the southern portion of the City. Once that site is selected, the order will be placed for purchase and installation. The total cost of this project will be approximately \$73,000.

City garden on Seeds of Hope tour

The garden of John and Dana Atkins on Gateway Lane is one of eight chosen for the 2009 Seeds of Hope Garden Tour.

The June 6 event benefits at-risk youths ages 16–24 living at the nonprofit Monroe Harding campus at 1120 Glendale Lane.

Register to reduce nuisance calls

If you're tired of telemarketers tying up your phone line and interrupting your dinner, you can sign up with the National Do No Call Registry to reduce nuisance calls.

Visit donotcall.gov to register your home or mobile telephone number for free. Most telemarketers should not call your number once it has been on the registry for 31 days. If they do, you can file a complaint at the site.

The registry became permanent in 2008—you do not have to re-register or update your account.

Some calls are exempt: calls from or on behalf of political organizations, charities, and telephone surveyors are permit-

ted, as are calls from companies with which you have an existing business relationship, or those to whom you've provided agreement in writing to receive their calls. For more information visit donotcall.gov.
